

**Coon Rapids High School Hockey Redline Club Meeting Minutes**

**I. Call to order:**

Present: Coach Mileski, Scott Draskowski, Becky Smith, Eric Frits, Jim Kirkeide, Judy Lemoine and Tammy Ostgard

**II. Coaches report/comments:**

Coach looked into the Student account and there was a balance of \$68.37 through the school. These funds are raised by students and if this is used to purchase items, the students own whatever is purchased.

**III: OLD BUSINESS:**

**a: Golf Tournament:**

We will not be coordinating the golf tournament with the Youth Hockey Association this year but will promote participation. This will be held at Victory Links Golf Course on September 17<sup>th</sup> and there will be something at CR's after the tournament. Coach Mileski would also like to support this by having the boys caddying, etc.

**b. Fundraising:**

**i. Poll results:**

Discussion was held on the results of the poll sent out by email to all parents. 11 chose the Blitz fundraising, 11 chose the flat fee and 10 didn't have an opinion.

**ii. Final Decisions:**

It was decided that the final decision would be a flat fee of \$300. Discussion was also held on the collection of the fee and it was decided that the collection would be the same as last year as a onetime fee. Scott will be sending out an email to all parents regarding the decision. Scott will also be asking for volunteers for a Fundraising Committee to put together some options for smaller fundraising opportunities to defray costs for parents if they choose to do so.

**c. Summer Camp Numbers update:**

Coach Mileski stated that due to low numbers for sign up, Bantams (14) and Peewees (8) will be combined. U/10, U/12 Girls will be combined with Squirts for a total of 22 and U/14 Girls and High School Girls will be combined for a total of 17. 25 for High School Boys.

**d. 2011-2012 Budget planning revisited/finalized:** 2011/2012 Budget was finalized.

**e: New Jerseys:** Discussion was held and the two bids (Champlin Athletics and Steichen's Sporting Goods) were very close, approximately \$85/jersey, so it was decided that we would look into a firmer price from Champlin Athletics since we have worked with them in the past. Coach Mileski will look at which jersey and get a more precise bid with lettering, etc. and will report back at the next meeting.

**a. Signed Player Waivers for ice times:** Scott will be emailing all parents the Sunday Night Ice, August Ice and Captain's Practice schedule and will include the Signed Player Waiver. This form will be required before they can participate.
